PROFESSOR VAJIRA DISSANAYAKE

Professor Vajira Dissanayake MBBS PhD is the Chairperson of the Commonwealth Health Professions and Partners Alliance (since 2021). He is Chair and Senior Professor in the Department of Anatomy, Genetics, and Biomedical Informatics and the Dean of the Faculty of Medicine, University of Colombo, Sri Lanka. He is a pioneer in Genetics, Genomics, Biomedical Informatics and Bioethics in Sri Lanka. Professor Dissanayake has held many leadership positions in the field of medicine. He was the President of the Sri Lanka Medical Association in 2012; President of the Commonwealth Medical Association from 2016 to 2019; Chairperson, Commonwealth Centre for Digital Health (since 2018); and current President of the Sri Lanka Medical Council.



HER EXCELLENCY BARONESS PATRICIA SCOTLAND KC

The Rt Hon Patricia Scotland KC took office as the 6th Secretary General of the Commonwealth on 1 April 2016. She was the first woman to be elected to the position. Patricia Scotland trained as a lawyer and became the first black women and the youngest woman to be appointed a Queen's Counsel (QC) in 1991. She was the first black woman to be appointed Deputy High Court Judge, Recorder and Master of Middle Temple. Patricia joined the House of Lords in 1997 as Baroness Scotland of Asthal going on to serve as a minister in the Foreign Office, Home Office and Lord Chancellor's Department. In this position, she undertook major reform of the criminal justice system including introduction of the Domestic Violence Crime and Victims Act. She was appointed Attorney General in 2007, the first woman to hold the post since it was created in 1315. Patricia founded the Eliminate Domestic Violence Global Foundation in 2011.



DR ANNE GALLAGHER AO

Dr Anne Gallagher AO is the Director General of the Commonwealth Foundation and is the Commonwealth's ambassador for civil society working closely with Member States to advance people's participation in all aspects of public dialogue. A lawyer, practitioner, teacher, and scholar, Anne's long international career has involved specialisation in a wide range of areas including human rights and the administration of criminal justice. Anne served for 12 years at the United Nations, including as special adviser to the UN High Commissioner for Human Rights. Anne also worked with the Association of South-East Asian Nations to strengthen legislative and criminal justice responses to human trafficking and related exploitation



ORITSÉ WILLIAMS

Oritsé Williams, musician, poet and founding member of the Band JLS, presented a BBC World Service programme on young carers in January (https://www.bbc.co.uk/sounds/play/w3ct4m2h). As a teenager, Oritsé was a young carer for his mother, Sonia Williams, who has Multiple Sclerosis. He and his siblings vowed to strive to find a cure for MS. He is proud to be the new Commonwealth Young Carer Champion working with Commonwealth Organisations to promote the Young Carers Charter. The Band has just announced a nationwide tour of 20 stadium venues (https://www.jlsofficial.com) which will raise the profile of young carers.



DR DAVID N JONES

Dr David N Jones qualified as a social worker in 1974 and has extensive international, national and local government, NGO and private sector experience. He is a Board Member of the Commonwealth Organisation for Social Work (COSW), represents civil society on the Commonwealth Advisory Committee on Health and is a Trustee of Children and Families Across Borders (ISS-UK). He was President of the International Federation of Social Workers (IFSW) 2006–10 and Global Coordinator of The Global Agenda for Social Work and Social Development (2010–2020). He has published and spoken extensively on social work practice and management in the UK and overseas.



DORCAS GWATA

Dorcas is a globally recognised, experienced and innovative mental health and public health nurse clinician, researcher, advisor and leader. She has the lived experiences of a hospital cleaner who became an award-winning nurse, a global health consultant, and climate change advocate. Dorcas has wide-ranging grassroots experience in designing and delivering innovative global health programs specialising in youth violence, mental health, the nursing diaspora, and nursing and health partnerships. Dorcas is highly experienced in working in government advisory roles advocating on ethical recruitments, health systems strengthening, equity and equality whilst navigating complex geo-political contexts. Dorcas is an African Affairs Analyst, Chair of Primary Care International, and an Advisor for the Tropical Health and Education Trust (THET).



OGWENO STEPHEN

Ogweno Stephen is a multi-award-winning global health practitioner, a non-communicable diseases (NCDs) advocate, and an innovator. His background is in Global health having studied at Cambridge University and the University of Manchester. He is known for his vast work in developing programs and innovations, aimed at improving health literacy and access to care for chronic diseases. As the founder and CEO of Stowelink Foundation based in Kenya, he has led the implementation of such programs in over 8 countries in Africa and continues to develop innovations to make health accessible to the next 1 billion Africans.



PROFESSOR DR J A JAYALAL

Professor Dr J A Jayalal is the Secretary General of the Commonwealth Medical Association 2022–2024 and was the National President of the Indian Medical Association 2020–2021. Dr Jayalal is Senior Consultant in Laparoscopic Surgery at Annammal Hospital, Kuzhithural Kanyakumari District, Tamil Nadu, India and Professor of Surgery Kanyakumari Government Medical College. On his election as Secretary General of the CMA Dr Layalal said that his priority would be ensuring affordable, accessible, sustainable and quality health care to all people of the Commonwealth. Dr Jayalal holds many prestigious positions including: National Head of the Indian Medical Association UNESCO Bioethics Initiative; Governing Council Member of the National Board of Examination (India); and Member of the Senate and Board of Studies, the Tamil Nadu Dr MGR Medical University.



GILLIAN NIGHTALL

Gillian Nightall is Clinical Director and Consultant Clinical Psychologist at Northamptonshire Healthcare NHS Foundation Trust. The Trust delivers many physical, mental health and speciality services in the community, offering care to more than 700,000 people. Services are delivered from many sites including hospitals, GP surgeries, clinics and in homes. Gillian works with families, individuals and couples where at least one family member has experienced significant mental illness. She has worked in children and adolescent and also adult mental health services. She is an experienced trainer and supervisor and is passionate about enabling teams to deliver quality care.



PROFESSOR TONY NELSON

Professor Tony Nelson is Clinical Professional Consultant and Professor of Practice in Paediatrics, Faculty of Medicine, Chinese University of Hong Kong. Tony has published widely on vaccine preventable diseases, infant and child nutrition, and sudden infant death syndrome. He has conducted studies on respiratory and diarrhoeal disease surveillance; influenza and rotavirus vaccine effectiveness; rotavirus vaccine efficacy and rotavirus vaccine economic evaluations. He chairs the Steering Committee of Immunization Partners in Asia Pacific. Tony coordinated Paediatric undergraduate teaching 1994–2020 and was a Faculty of Medicine Year coordinator 2005–2017. During this time, he has been involved in curriculum design and innovative projects to enhance student learning and participation.



ADAM ASPINALL

Adam Aspinall, Medicines for Malaria Venture (MMV) and Fight the Fakes Alliance. Adam is Senior Director, Access and Product Management, at Medicines for Malaria Venture (MMV), a Geneva-based Product Development Partnership engaged in the discovery, development and delivery of novel antimalarial medicines. In this role he is responsible for MMV's portfolio of in-development and launched drugs for uncomplicated malaria, and is also MMV's lead in the area of falsified and substandard medicines. In November 2020, Adam was elected as the first Chair of the Fight the Fakes Alliance, a new multi-stakeholder non-profit association dedicated to the fight against substandard and falsified medicines. Prior to joining MMV, Adam spent over 20 years in the pharmaceutical and biotech industry.
